CO14: Contract I

CO19: Constitutional Law

CO20: Family Law - I

CO21: Environmental Laws

This course promotes a basic scientific understanding of the environment, its deterioration and mandates for the protection of the biosphere and traces the development of environmental laws internationally and at the national level through judicial activism.

CO22: Drafting Pleading Conveyancing - I

In this course students are taught to draft basic applications, power of attorneys, vakalatnamas, etc. to develop their skills in drafting legal documents and framing various applications/letters in legally prescribed manner.
