## Seminar on Intellectual Property Rights (IPR)

It also encouraged them to make informed decisions and emphasised the importance of complementing intellectual property laws with competition laws in order to comprehend the broader legal framework, avoid anti-competitive practises, balance public interest, facilitate licensing and technology transfer, ensure compliance, participate in policy development, and navigate the international landscape.
