Objectives

Scope of Cooperation

- a. Exchange of information on research, teaching, learning materials and literature relevant to research programs through webinars, Legal Training, Legal aid, Guest lectures by the expertise as well as offering Courses in Multiple discipline in the field of Law.

Giving opportunities to attend seminars, Faculty Development Programs (FDP), conferences, workshops and short-term programs in the area of research through the expertise in the field of recent development, amendments in law, while extending invitations to each other's faculty to participate therein.
- c. Other areas as mutually agreed upon by the Parties.

Dispute Settlement

The Parties hereby agree that they will consult together upon request of either party regarding any matter relating to the terms of this MOU and will endeavor jointly in a spirit of cooperation and mutual trust to resolve any difficulties or misunderstandings which may arise.

If any part of this Agreement is determined to violate national, state, or local laws, rules, or regulations, the parties agree to negotiate in good faith revisions to any such provisions. If the parties fail to agree within a reasonable time to revisions required to bring the entire Agreement into compliance, either party may terminate this Agreement upon thirty (30) days prior written notice to the other party.

Entire Agreement

This Agreement constitutes the entire agreement and understanding between the parties as to the subject matter hereof and supersedes all prior discussions, agreements and undertakings of every kind and nature between them, whether written or oral, with respect to such subject matter. This Agreement may subsequently be modified only by a written document executed by both parties.

Duration and Evaluation

This MOU will come into effect on the date of signature by the representatives of the two institutions. Either party may request termination of this agreement, in writing, Thirty (30) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing. A joint evaluation of the MOU will be initiated by the designated representatives Three (3) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.

- e) This MoU may be amended, renewed and terminated by mutual written agreement of the Institutes at any time.
- f) Either Institute shall have the right to terminate this MoU upon 30 days prior written notice to the other Institute.
- g) On mutual consent of both the Institutes, review meetings will be conducted once in three months with Co-ordinator's and Principals.

5. CONFIDENTIALITY:

The Institutes agree to hold in confidence all Information/data designated by the Institutes as being confidential which is obtained from either Institute or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other Institute.

6. DURATION OF MOU:

This MoU, unless extended by mutual, written consent of the institute, shall expire in **Five years** after the effective data specified in the opening paragraph. However. on review of, the MOU shall be extended for another **Two** years by mutual consent.
