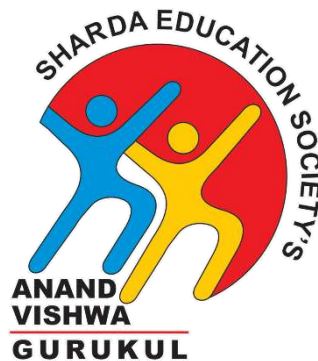

- All the faculty members adhere to the guidelines laid down by the University of Mumbai, Circular No UG/124/2018-19 for internal assessment. All faculty members follow diverse internal assessment strategies to evaluate the students in different domains of knowledge and understanding.
- The institution in accordance with University of Mumbai guidelines assigns 40% of the internal marks in each paper in undergraduate courses for Internal Assessment and the remaining 60% marks for the external assessment.

A. Criminal Procedure Code, 1973, Section 428 - Period of detention undergone by accused to be set off against sentence or imprisonment - It cannot be lost sight that when reference is made in set off for adjustment of periods, the reference is to proceedings within country - Criminal law of land does not have any extra-territorial application - Thus, what happens in another country for some other trial, some other detention, would not be relevant for purposes of proceedings in country - Thus, accused cannot claim double benefit under section 428 of the Cr.P.C., 1973.

B. Separation of Judicial and Executive powers - Cannot bind Indian courts in proceedings under Extradition Act - Thus, courts must proceed in accordance with law and impose sentence as law of land requires, while simultaneously Executive is bound to comply with its international obligations under Extradition Act as also on principle of comity of courts, which forms basis of extradition.

Q. 1 Discuss the salient features of Indian Constitution.

Ans. The Constitution of India is largest and most detailed Constitution in world. It originally consisted of 395 Articles divided into 22 parts and 8 schedules. The framers of Indian Constitution sought to incorporate the good provisions of all the existing constitutions of different countries in the world. Indian Constitution has borrowed Parliamentary system of Government from British Constitution. Framers of Indian Constitution incorporated provisions of 'Fundamental Rights' from the Constitution of United States of America, 'Directive Principles of State Policy' from Ireland, Power of Judicial Review to the Supreme Court has been taken from the Constitution of United States of America. Similarly India's federalism has been benefited from American provisions in this area. The Constitution of Canada and Australia have also been used to some extent for laying down some provisions of Constitution of India. The Constitution of India Occupies a unique place among the federal Constitutions of the World. This is due to its distinctive features. The chief characteristics of Indian Constitution are as follows :-

1. Longest Constitution of the World - The Indian Constitution is lengthiest and most detailed of all written Constitutions of the world. While the American Constitution originally consisted of 7 Articles, Australian Constitution 128 and Canadian Constitution 147 and Indian Constitution originally had 395 Articles. But till 78 the Amendment Act, of 1995 it consists of 443 Articles. The Indian Constitution lays down the structure not only of Central Government but also of the States. The American Constitution on the other hand leaves the States to draw up their own Constitution. Because of peculiar problem of India like population, minorities, schedule class, Schedule tribe community peoples it had to incorporate many provisions.

2. Democratic form of Government. - The Constitution of India constitutes India into a sovereign democratic republic. It thus provides for the establishment of a democratic form of government in the country. Justice, Liberty, Equality and Fraternity which are essential characteristics of a Democracy are declared in the Preamble as the main objectives of the constitution. In a democracy the Government

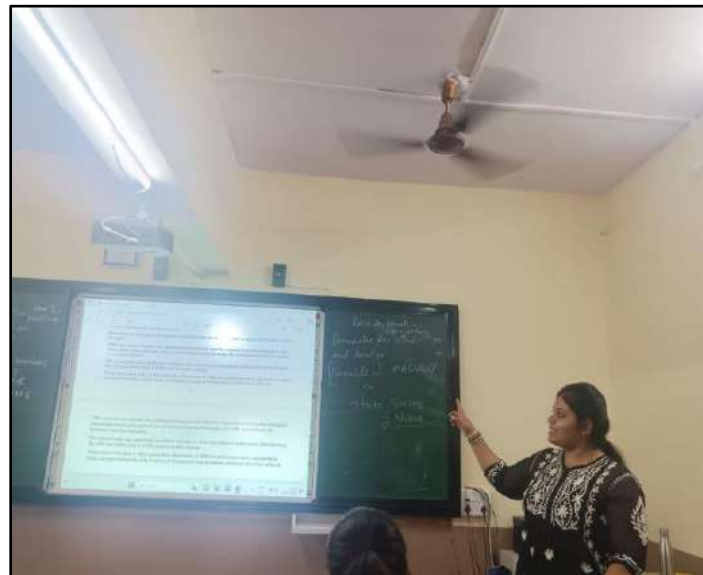

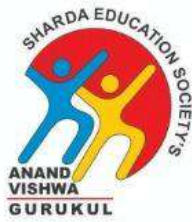

The software runs on windows platform in client/server mode. The infrastructure requirements (hardware, operating system, database management software, internet connectivity, etc.) for using the software are specific. E-Granthalaya 3.0 uses MS SQL Server (any edition) as backend database software and VB.NET/ASP.NET 2.0 as frontend solution. Express edition of SQL Server is provided free along with e-Granthalaya software.

The software is made available free of charge to libraries under e-governance initiative of the Government of India. However, the recipient library has to pay the charges for installation of the software, training of staff and post-installation technical support and service.

E-Granthalaya is complete and integrated bibliographic software. It is user friendly. It covers the following modules:

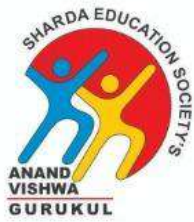

Z39.50 Protocol. In the case where internet connectivity is available, it is possible to upload or import catalogue records from the Library of Congress and other libraries so that there is no need to enter bibliographic details manually in the database. This feature is known as copy cataloguing in library parlance.

Multilingual (Unicode) Facility. Apart from books in English language, it is possible to enter information about books written in Indian regional languages such as Marathi, Hindi, Gujarati, Kannada, etc. The software is Unicode compliant.

OPAC (Online Public Access Catalogue): Provides access to complete backend database for searching which includes options from a simple search to an advance search. It is especially useful for faculty and students. OPAC gives access to books, journals, etc. to make your library's database available on the LAN.
