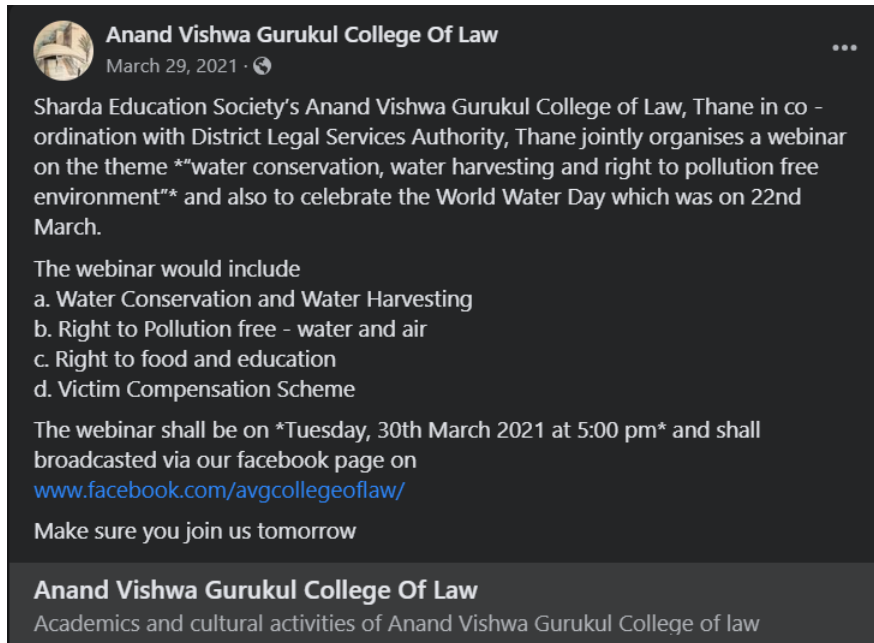

Report on Webinar on Water Conservation, Water Harvesting and Right to Pollution Free Environment

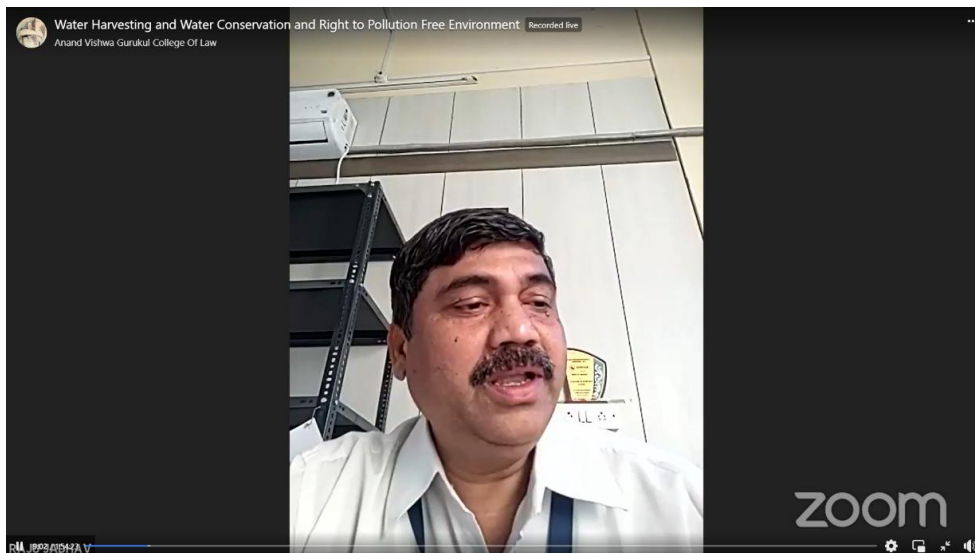


A Webinar on Water Conservation, Water Harvesting and Right to Pollution Free Environment was conducted by Anand Vishwa Gurukul College of Law in co-ordination with District Legal Services Authority, Thane (DLSA) on **30th March 2021 at 5 pm** to commemorate **World Water Day** which is celebrated on 22nd March every year. The webinar was broadcasted via Facebook Live. Due to suspension of physical meetings, the notice for the webinar was shared via the college Facebook Page to ensure maximum outreach among the stakeholders and also general public. The webinar included sessions on **Right to Pollution free water and air, Water Harvesting and Water Conservation, Right to Food and Education, Schemes introduced by the Women and Child Department, Govt. of Maharashtra and Victim Compensation Scheme**. A brief summary of each session is presented hereunder:

1. **Right to Pollution-free water and air**

The keynote speaker for the session was **Mr. Raju Jadhav** who is an environmental scientist at Thane Pollution Control Cell. Mr. Jadhav highlighted the major aspects of right to clean environment as enshrined in the Constitution of India. While doing so, he also emphasized on the correlative duties of citizens to maintain a clean and healthy environment.

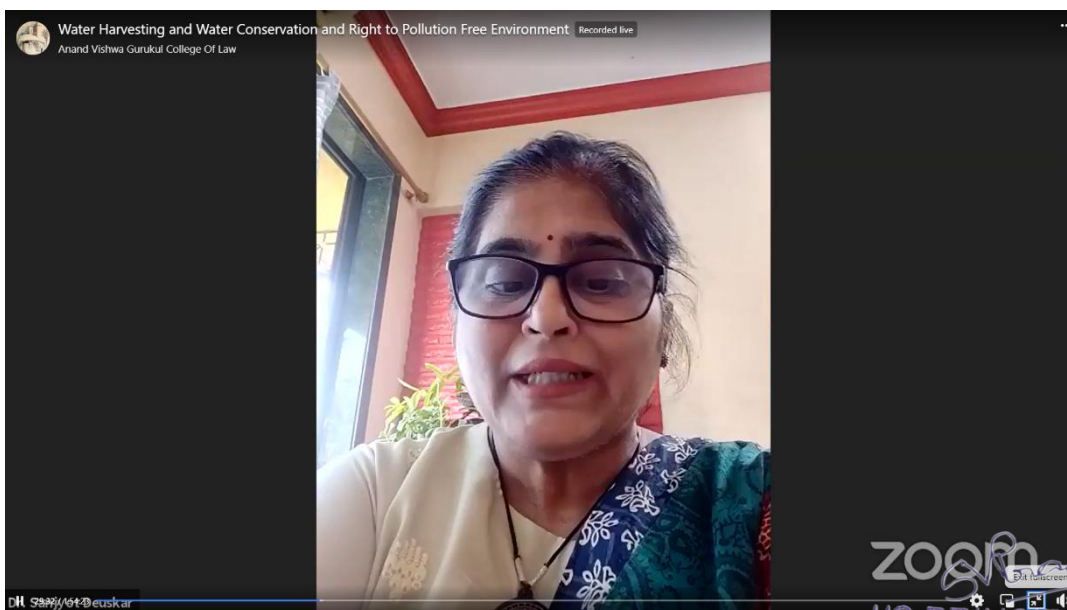

2. Water Harvesting and Water Conservation

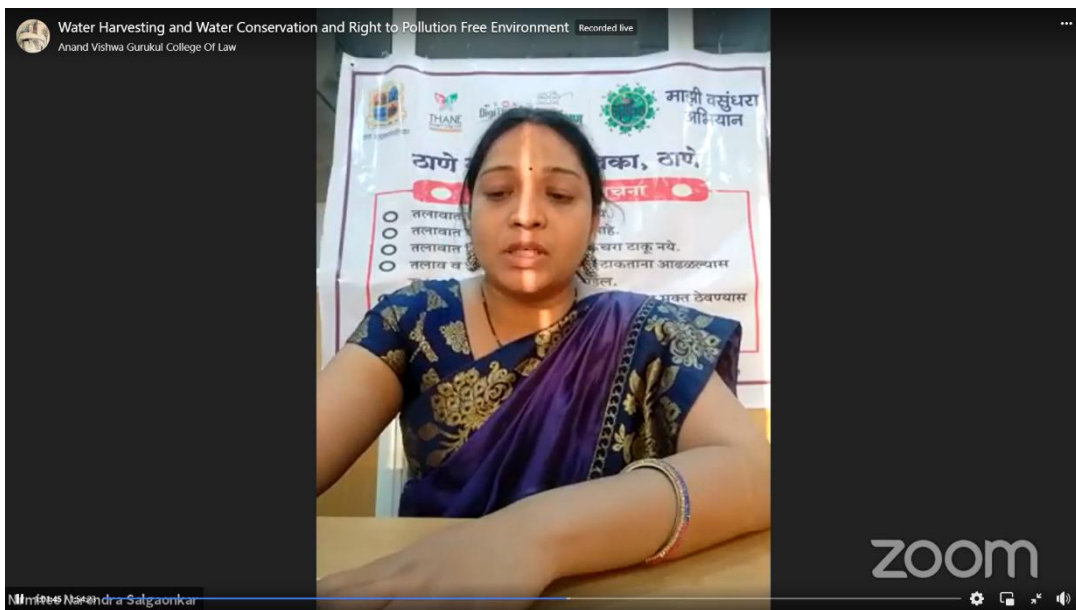
The speaker for this session was **Dr. Sanjyot Deuskar**. Dr. Deuskar is Vice-Principal at Satish Pradhan Dyansadhana College and a member of the Bombay Geographical Association. Dr. Deuskar highlighted the importance of Water Conservation and Water Harvesting and encouraged the audience to adopt simple yet impactful habits in their daily lives to contribute to this essential cause.

Further into the session, **Mrs. Nirmitee Salgaonkar** who is a Junior Scientist at Pollution Control Board, Thane explained the importance of water conservation and harvesting and appropriate waste management. Mrs. Salgaonkar also highlighted the efforts undertaken by Thane Municipal Corporation in preserving the lakes and water bodies in Thane city.

3. Schemes introduced by the Women and Child Department, Govt. of Maharashtra

The keynote speaker for the session was **Mr. Kamlesh Deshmukh**. Mr. Deshmukh is a Protection Officer at the Women and Child Department, Government of Maharashtra. Mr. Deshmukh introduced various schemes like appointment of Protection Officers in all Talukas of Maharashtra in January 2015, through which the victims of domestic violence can file a complaint in the courts and implementation of orders granted by the Hon'ble Courts. Establishment of One Stop Centres (OSC) for women which provides medical attention, psychological counselling, legal aid and all other essential services under one roof. He also briefed about other welfare schemes like working women's hostels, child care centres, etc.

4. **Right to Food and Education**

Advocate Rajendra Nalge, a prominent lawyer noted for his work in Thane's District and Sessions Court and as a respected member of the Thane District Legal Service Authority, emphasised the need of subsistence through food and development through education. He elucidated that the Right to Food is an integral aspect of the Fundamental Right to Life enshrined in the Indian Constitution. Furthermore, he detailed the origins and significance of the National Food Security Act of 2013.



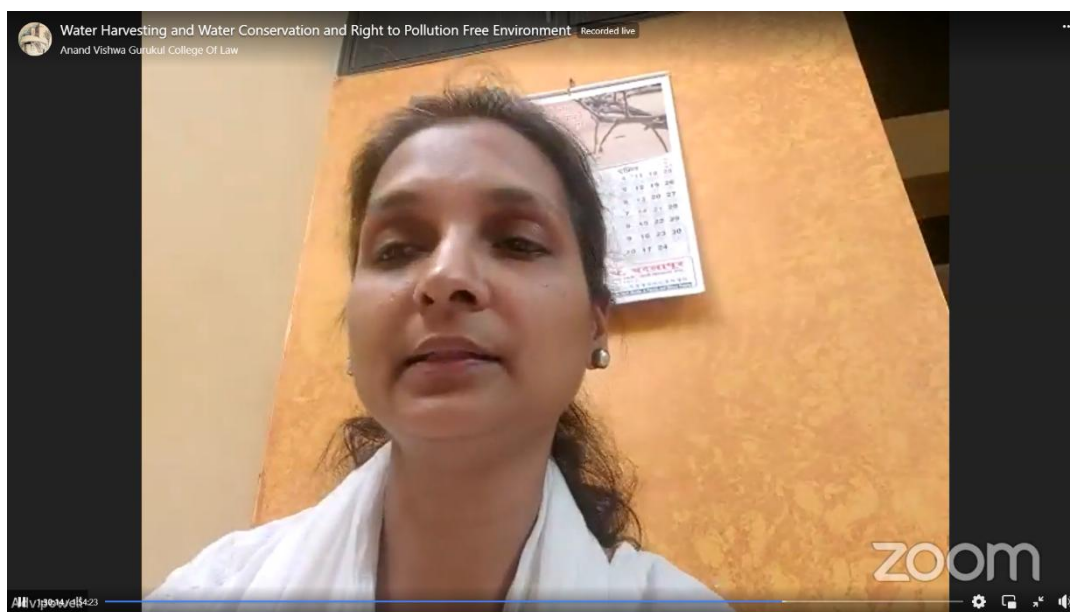

Advocate Nalge also educated the audience on the Right to Education, as specified expressly in the Right of Children to Free and Compulsory Education Act of 2009. He emphasised the act's significant role to securing elementary education, particularly for children aged 6 to 14 years.

5. Victim Compensation Scheme

The speaker for the final session of the webinar was **Advocate Ushakiran Powell**. Adv Powell is an advocate at the District and Sessions Court and a member of the District Legal Services Authority, Thane. Adv. Powell elaborated the provisions of the Victim Compensation Scheme 2013. The scheme outlines the provisions for victims of child abuse (under POCSO Act), victims of rape (as defined under Indian Penal Code), acid attack (as defined under Indian Penal Code) and victims of Immoral Traffic (Prevention) Act. Apart from processing the crime, Adv. Powell also explained the importance of sensitization of the process and special care and protection of the victims, as per the guidelines of the Scheme.

The key speaker for the webinar was Dr. Jerryl Banait who has been actively working for the cause of wildlife conservation. Dr. Banait, a dermatologist by profession, an RTI Activist and is also the Chairman of the AVI Foundation, which has been working in different disciplines such as wildlife conservation and protection of migratory corridors. Dr. Banait has filed numerous Public Interest Litigations in the Hon'ble High Court and the Hon'ble Supreme Court for the voiceless animals and people in need, one of which was the PIL filed before the Hon'ble High Court of Bombay at Nagpur against the 'shoot at sight' order against the alleged man-eater tigress T1- Avni.

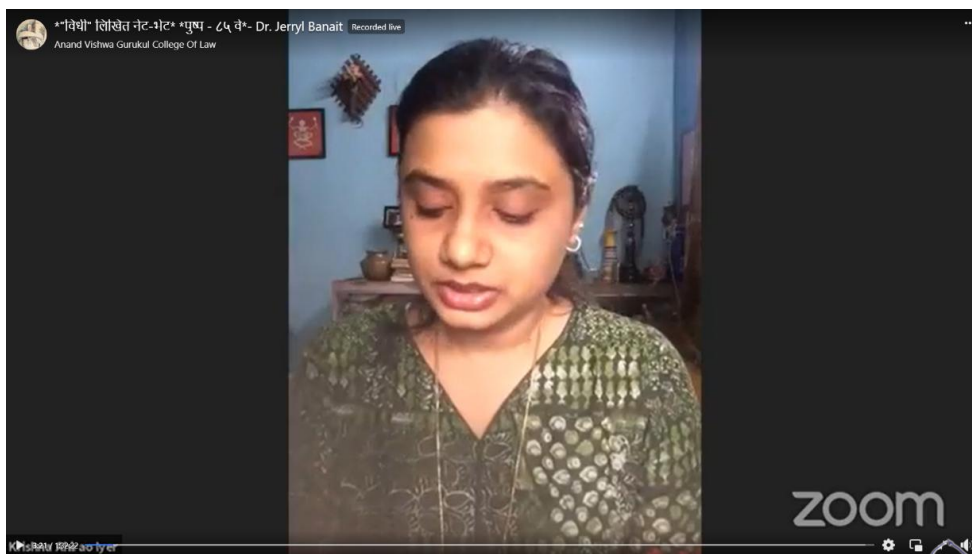

The session commenced with the welcome note by our I/C Principal Adv. Suyash V. Pradhan. His opening remarks conveyed the institution's enthusiasm for hosting the event on tiger conservation. Prof. Krishna Ahirao-Iyer then provided a concise yet insightful introduction of the esteemed guest speaker, Dr. Jerryl Banait. Prof. Ahirao-Iyer's introduction highlighted Dr. Banait's notable contributions towards wildlife conservation and his expertise in tackling intricate legal matters related to conservation.

In his address Dr. Banait shared his experiences with wildlife. He introduced the audience to the importance of tigers to maintain a healthy ecological balance. Dr. Banait also briefly discussed the National Tiger Conservation Authority which is the NODAL agency for tiger conservation in India.

Dr. Banait also educated the audiences about the difference between 'man-animal conflict' and 'man-eater killing' and the significance of accurately identifying the underlying causes of conflicts between humans and animals, particularly focusing on tigers in this context. Dr. Banait aimed to raise awareness about the complexities of interactions between humans and wildlife, as well as the need for informed decision-making and the implementation of effective strategies to address these conflicts while ensuring the safety of both humans and animals, most prominently being proper tranquilizing and need for certified wild life veterinarians.

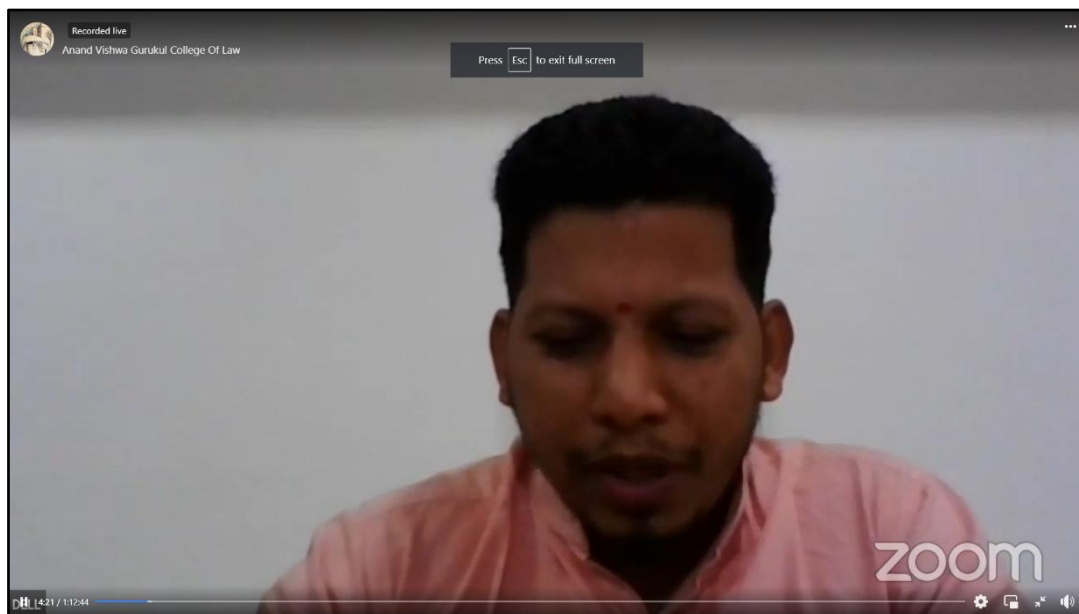

participants. Prof. Krishna Ahirao-Iyer, a respected figure in the academic community, provided a concise yet insightful introduction of the guest speaker. Her introduction shed light on Mr. Kadav's outstanding contributions to snake rescue and conservation, setting the tone for an informative session.

During his presentation, Mr. Shyam Kadav shared captivating anecdotes from his experiences as a snake rescuer. He elaborated on the challenges and rewards associated with his work, providing the audience with a firsthand glimpse into the world of snake rescue. Additionally, he emphasized the critical role that public awareness and education play in fostering a harmonious coexistence between humans and snakes and the importance of snakes in balancing the food chain.

In this interactive session, Mr. Kadav addressed many concerns ranging from essential preparation and caution taken by snake rescuers, classification of snakes on the basis of venom, production of anti-venoms, first aid in case of snake bites, authentication of snake rescuers, superstitions and myths related to snakes, illegal use of snakes in promoting superstition, captivity and trafficking of snakes, misrepresentation of snakes in entertainment media, safety measures to be undertaken by relief camp workers visiting forest areas.

In his address, Mr. Kadav addressed concerns about snake bites being a cause large number of deaths in India. He clarified that the high probability of death is due to improper preliminary medication to the afflicted, rather than the affliction itself. Mr. Kadav also raised

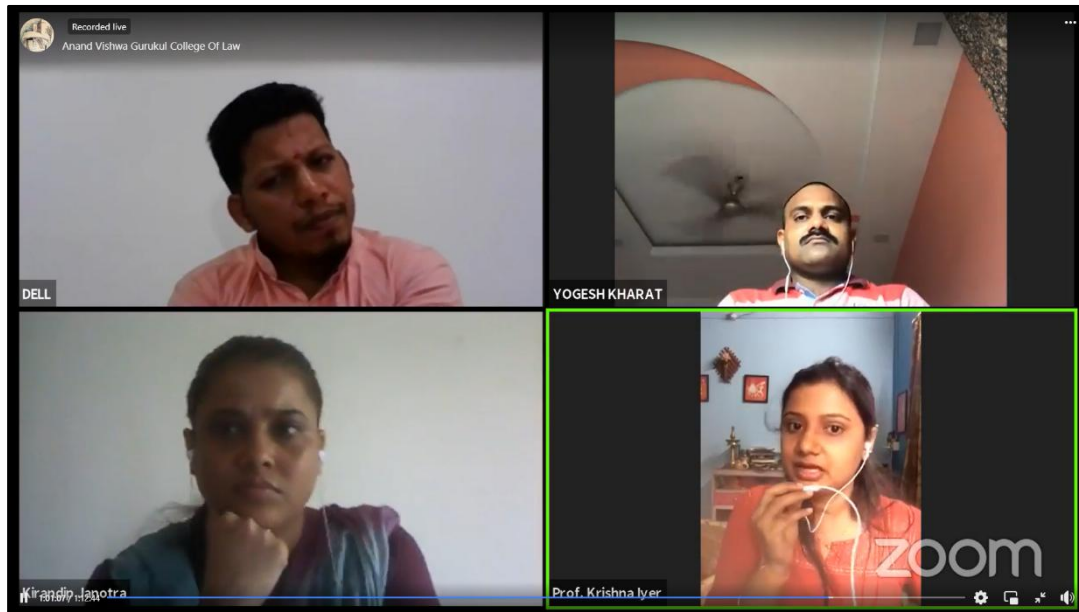
