Code of Conduct and Ethics for Students

Sharada Education Society's Anand Vishwa Gurukul College of Law is dedicated to provide holistic development of its students. To ensure positive reception of the same, the students are expected to demonstrate integrity and behaviour in consonance with the ideals of the institution. It is incumbent upon the students to follow the code of conduct and ethics as outlined below:

- (1) All students are expected to treat each other, faculty, staff, and visitors with respect, dignity, and fairness and refrain from discrimination, harassment, bullying, or any form of disrespectful behaviour based on race, ethnicity, gender, religion, disability, or any other characteristic.
- (2) Students must not be involved in any form of ragging which may cause physical or psychological harm or fear among any other students such as:
 - any conduct by any student/students whether by words spoken or written or by an
 act which has the effect of teasing, treating or handling with rudeness any student;
 - indulging in rowdy or undisciplined activities by any student or students which
 causes or is likely to cause annoyance, hardship, physical or psychological harm or
 to raise fear or apprehension thereof in any other student;
 - asking any student to commit any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such a student;
 - any act by a senior student that prevents, disrupts oi disturbs the regular academic activity of any student;
 - Exploiting the services of a student for completing the academic tasks assigned to an individual or a group of students;
 - any act of financial extortion or forceful expenditure burden put on a student by other students;
 - any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to any other student;

- (3) Students must uphold the highest standards of academic integrity. This includes submitting original work, providing proper citations for sources, and refraining from any form of cheating or plagiarism in examinations, assignments, and other academic activities.
- (4) Each student is accountable for their actions and choices. Engaging in behaviours that endanger the safety, well-being, or reputation of oneself or others is strictly prohibited.
- (5) Smoking on the campus of the Institute, possessing, consuming, distributing, selling of alcohol or drugs in the Institute is prohibited.
- (6) Students must read notices displayed on college notice board and college website from time to time. Ignoring the notice will not be accepted as an excuse.
- (7) Students should not record audio or video record the lectures in the classroom.
- (8) Students are expected to use social media with utmost care and responsibility. They cannot post disparaging comments about other individual/s from the college on social media or indulge in any such activity that affects the reputation of the Institute.
- (9) Students must come decently dressed in the college.
- (10) Students should use digital technology ethically, respecting the privacy of others and demonstrating responsible behaviour while interacting online or using digital resources.
- (11) Any form of plagiarism or cheating is strictly prohibited. Students must give proper credit to all sources used in their academic work and not misrepresent the work of others as their own.
- (12) Signing another student's name on a project, assignment, research paper, etc. is not acceptable.
- (13) Resorting to any sort of unfair means, cheating, carrying written material, use of electronic equipment, etc. during examination is strictly prohibited. Any person found doing so shall be dealt with as per the University Rules and Regulations
- (14) Students are expected to attend all classes regularly and punctually. Disruptive behaviour that interferes with the learning experience of others will not be tolerated. As per University mandate if a student fails to maintain at least 75% attendance, they shall not be permitted to appear for the exams.
- (15) Students should use campus facilities and equipment responsibly, avoiding any misuse or damage to property.
- (16) Students are expected to handle library resources with care and return them on time.

 Theft or defacement of library materials is strictly prohibited.
