IQAC (Internal Quality Assurance Cell) will prepare and disseminate a notice to all stakeholders, inviting them to provide feedback on the syllabus and course content.

2.2. Orientation Sessions:

Orientation sessions will be organized for students to emphasize the significance of feedback and its role in curriculum enhancement. These sessions will highlight the actions taken by the institution based on previous feedback responses.

2.3. Questionnaire Distribution:

Students and alumni will be shared link through email, who will complete the feedback questionnaire and submit. Students are encouraged to obtain feedback from employers, advocates, law firms, and other relevant professionals.
