
Where as School decided to start Computer Laboratory Setup at their premises with the help of Thorve Enterprises.

DUTIES AND RESPONSIBILITIES OF THE SCHOOL.

The School shall—


1. Submit to Trustees in the documentary form
 - a. Details of the Franchisee
 - b. After completion of the course, the detailed report mentioning the no. of students enrolled passed, progress, evaluation of the course by students' suggestions etc.
2. Initially make the Compulsion for the std I to Sr college
3. Undertake to provide specific infrastructure facilities as mentioned below to franchisee.
 - a. One practical hall of 500 sq. ft. full time.
 - b. One theory classroom as per availability & requirement of franchisee adjusting the timetable of the School.
 - c. Drinking water, toilet facilities.
 - d. Electricity & Telecommunication.
4. Ensure the smooth conduct of the courses exclusively in the premises of the School.
5. School should take proper precautions of Safety and security for the LAB and Students. .
6. Issue the final printed Certificates to the passed out students. .
7. Disburse 70%-30% (70% share will go to Thorve Enterprises & 30% to the School) Share of the student fees on or before 15th of every month. (Rs. 150/- per month per school student i.e. Rs. 1800 per annum per student .
8. Disburse 50%-50% (50% share will go to Thorve Enterprises & 50% to the Junior as well as senior College) Share of the student fees on or before 15th of every month..
9. Collect the course fee from the Learners admitted.
10. This agreement is valid for period of Ten years from the date of signature. -

III GENERALS CLAUSES:

1. It is the endeavor of the parties here to that this relationship will be initially for a minimum period of Ten years from the 'date of the signing of the agreement. This agreement can be continued up to maximum at will after obtaining satisfactory performance report of franchisee from Principal.

2. This agreement will come into force w.e.f. 1/06/2018 to 1/06/2028.

3. This agreement will expire on completion of Ten years w.e.f. the date as mentioned in the generals clause 2 above.

4. It needs- to be repeated that this is a performance based relationship agreement and satisfactory performance and maintenance of minimum standards is the key criteria for the continuation of relationship amongst between the parties hereto. It is mandatory for all the parties to carry out their responsibilities and duties as mentioned under this agreement.

The performance would be judged by the TRUSTEES based on the feed back of the learners.

5. School reserves the right to inspect the activities without any prior notice to franchisee.

6. The infrastructure provided by the Franchisee shall remain "Sole Property of Thorve Enterprises" during and after the tenure of this agreement.

7. The course fee and other charges and related cost if applicable, shall be first deposited with bank account and would be then distributed to the respective parties in accordance with sharing pattern given below in this agreement.

8. The total twelve month fee collected from the learners for the course will be shared between School and the franchisee. i.e. School share shall be 30% and franchisee share shall be 70% of the fees.

9. The fees collected from the learners shall be non- refundable and non-transferable under any circumstances-

Note: Franchisee or school shall not promise the refund or transfer of fees to any learner.


10. All the parties agree not to disclose or divulge any information or process or advice received or known from' each other or from any body else in the process of performance of this agreement without the knowledge and written consent of the other party , which many prove to be detrimental to the beneficial performance of this agreement .


11. Signing of these agreements shall result in cancellation and replacement of all past agreements amongst the parties here to whether in writing or other wise.

12. Any provision under these agreements is found or proved to be illegal or invalid then only that provision shall be treated as null and void and remaining part shall be considered as enforceable and valid.

II DUTIES AND RESPONSIBILITIES OF THE FRANCHISEE

The Franchisee shall:-

1. Treat the validity of this agreement minimum period of Ten years. .

2. Thorve Enterprises, will invest the required sum for the capital costs for creation of Computer Lab and equipments with suitable infrastructure, furniture, and fixtures, Computers and other equipments as per requirement for the standard setup. .

3. No right to utilize the fees collected from the students before share distribution.

4. Motivate the students, parents, teachers and guardians jointly with School.

5. Note that inward / outward movements of assets, men and materials will be recorded for the sake of safety, and accountability. Especially outward movements of assets, men and material would be only with written concurrence of the principal and security in charge of the School.

6. Suitably design regular academic activities to enable all the students to avail minimum hours per week of access to theory & practical in such a manner as to ensure optimum utilization of the infrastructure and computing facilities at the disposal.

7. Ensure implementation of the course as per the specification and quality standards stipulated by the Board, Ensure the availability of stipulated number of qualified staff for the teaching, practical, co-ordination marketing evolution, system administration e'tc. Impart the training as per the stipulated Syllabus and conducting at least two progressive evaluation tests during the course so as to achieve the desired competencies on the part of learners.

8. Collect the feedback from the learners for improvement of course delivery as per the guidelines given by School and take necessary corrective actions from time to time.


9. Ensure the safety and insurance of his invested/ mobilized assets.

10. Give wide publicity; carry out advertisement and promotion among the potential learners for the course advertisement to be given in the name of School.

11. Undertake to provide suitable remuneration to staff & faculties.

12. Designate one of their officials / person with adequate responsibility & authority as assign point interface to lease with the School and Trustees on all issues pertaining to the smooth operations of the Training Centre.




