

Minutes of the meeting:

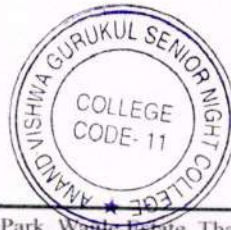
